

# ARP ESSER Health and Safety Plan Guidance & Template

Section 2001(i)(1) of the American Rescue Plan (ARP) Act requires each local education agency (LEA) that receives funding under the ARP Elementary and Secondary School Emergency Relief (ESSER) Fund to develop and make publicly available on the LEA's website a *Safe Return to In-Person Instruction and Continuity of Services Plan*, hereinafter referred to as a *Health and Safety Plan*.

Based on ARP requirements, 90 percent of ARP ESSER funds will be distributed to school districts and charter schools based on their relative share of Title I-A funding in FY 2020-2021. **Given Federally required timelines, LEAs eligible to apply for and receive this portion of the ARP ESSER funding must submit a Health and Safety Plan that meets ARP Act requirements to the Pennsylvania Department of Education (PDE) by Friday, July 30, 2021, regardless of when the LEA submits its ARP ESSER application.** 

Each LEA must create a Health and Safety Plan that addresses how it will maintain the health and safety of students, educators, and other staff, and which will serve as local guidelines for all instructional and non-instructional school activities during the period of the LEA's ARP ESSER grant. The Health and Safety Plan should be tailored to the unique needs of each LEA and its schools and must take into account public comment related to the development of, and subsequent revisions to, the Health and Safety Plan.

The ARP Act and U.S. Department of Education rules require Health and Safety plans include the following components:

- How the LEA will, to the greatest extent practicable, implement prevention and mitigation
  policies in line with the most up-to-date guidance from the Centers for Disease Control and
  Prevention (CDC) for the reopening and operation of school facilities in order to continuously
  and safely open and operate schools for in-person learning;
- How the LEA will ensure continuity of services, including but not limited to services to address
  the students' academic needs, and students' and staff members' social, emotional, mental
  health, and other needs, which may include student health and food services;
- 3. How the LEA will maintain the health and safety of students, educators, and other staff and the extent to which it has adopted policies, and a description of any such policy on each of the following safety recommendations established by the CDC:

- a. Universal and correct wearing of masks;
- b. Modifying facilities to allow for <a href="physical distancing">physical distancing</a> (e.g., use of cohorts/podding);
- c. Handwashing and respiratory etiquette;
- d. Cleaning and maintaining healthy facilities, including improving ventilation;
- e. <u>Contact tracing</u> in combination with <u>isolation</u> and <u>quarantine</u>, in collaboration with State and local health departments;
- f. <u>Diagnostic</u> and screening testing;
- g. Efforts to provide COVID-19 vaccinations to school communities;
- h. Appropriate accommodations for children with disabilities with respect to health and safety policies; and
- i. Coordination with state and local health officials.

The LEA's Health and Safety Plan must be approved by its governing body and posted on the LEA's publicly available website by July 30, 2021.\* The ARP Act requires LEAs to post their Health and Safety Plans online in a language that parents/caregivers can understand, or, if it is not practicable to provide written translations to an individual with limited English proficiency, be orally translated. The plan also must be provided in an alternative format accessible, upon request, by a parent who is an individual with a disability as defined by the Americans with Disabilities Act.

Each LEA will upload in the eGrants system its updated Health and Safety Plan and webpage URL where the plan is located on the LEA's publicly available website.

The ARP Act requires LEAs to review their Health and Safety Plans at least every six months during the period of the LEA's ARP ESSER grant. LEAs also must review and update their plans whenever there are significant changes to the CDC recommendations for K-12 schools. Like the development of the plan, all revisions must be informed by community input and reviewed and approved by the governing body prior to posting on the LEA's publicly available website.

LEAs may use the template to revise their current Health and Safety Plans to meet ARP requirements and ensure all stakeholders are fully informed of the LEA's plan to safely resume instructional and non-instructional school activities, including in-person learning, for the current school year. An LEA may use a different plan template or format provided it includes all the elements required by the ARP Act, as listed above.

\* The July 30 deadline applies only to school districts and charter schools that received federal Title I-A funds in FY 2020-2021 and intend to apply for and receive ARP ESSER funding.

How will the LEA, to the greatest extent practicable, support prevention and mitigation policies in line with the most up-to-date guidance from the CDC for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning?

Catalyst Academy CS will align its practices with the guidance provided by the Centers for Disease Control (CDC) *Operational Strategy for K-12 School Through Phased Prevention* and the Pennsylvania Department of Education's *COVID-19 Resources for Pre-K to 12 Schools* to ensure safe option of full in-person instruction throughout the 2021-2022 school year.

1. How will the LEA ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services?

Catalyst Academy CS will provide full in-person instruction to meet student's academic and health needs. The organization will closely monitor transmission rates in Allegheny County and, in consultation with the Allegheny County Health Department, will make decisions about mandated distance learning if indicated. Student services including school health, school counseling, and nutrition will continue to operate during a potential distance learning scenario.

Universal and correct wearing of masks; | Beginning on March 4, 2022, consistent with revised CDC guidance issued February 25, 2022 on masks, and the "Low" COVID-19 Community Level (as determined by CDC metrics) in Allegheny County, the wearing of masks will be optional, though masking will still be encouraged for students, staff and visitors to the school building. Consistent with CDC guidance, if the Allegheny County |

COVID-19 Community Level rises to a "High" level for a period of at least two consecutive weeks, masks would be required of students, staff, and visitors until the level drops below "High" again. Catalyst Academy will comply with any future requirements issued by PDE and/or the Allegheny County Health Department with regard to masking of students, staff, and school visitors and all other mitigation measures. Catalyst Academy students that ride a school bus to school will be required to adhere to the bus masking policies established by their school districts of residence and/or the companies operating their specific bus route. b. Modifying facilities to allow for physical If the CDC determines that Allegheny County's COVID-19 Community Level is distancing (e.g., use of cohorts/podding); "High" for at least two consecutive weeks, Catalyst Academy will seek to keep students and staff at least three feet apart when feasible in educational and communal environments. c. Handwashing and respiratory etiquette; Students will be encouraged and provided with transition time to accommodate hand washing and hand sanitizing during specific times of the school day. Signage for handwashing will be displayed to remind students of proper handwashing procedures. Adequate supplies (i.e. soap, paper towels, hand sanitizer, facial tissue) to support healthy hygiene practices will be available. All classrooms will be provided with alcoholbased hand sanitizer that contains at least 60% alcohol. Hand sanitizer will also be located in several areas of the building including all entrances and exits. Instruction on proper hand washing and respiratory etiquette will be provided to students regularly.

d. <u>Cleaning</u> and maintaining healthy facilities, including improving <u>ventilation</u>;

#### Cleaning

Catalyst Academy CS will follow the CDC's Guidance for Cleaning & Disinfecting Schools.

Frequently touched surfaces and objects within the school will be cleaned and disinfected at least daily. This includes, but is not limited to, door handles, sink handles, and drinking fountains.

Appropriate staff will be trained on safe and correct storage of cleaning and disinfecting products.

#### Ventilation

HVAC systems for most classrooms and common areas have been upgraded in 2020-2021. The upgraded system monitors air quality and brings in additional fresh air as needed.

e. Contact tracing in combination with isolation and quarantine, in collaboration with the State and local health departments;

Catalyst Academy CS has an isolation area which will be used for staff, students, or visitors who demonstrate COVID-19 symptoms while at school. The Leadership Team will use these isolation areas to house students until their parents/guardians retrieve them. Immediate pick-up will be mandated.

Students, staff, or visitors who exhibit symptoms of COVID-19 or a history of exposure will be sent home immediately and will stay away from the school premises until requirements for isolation or quarantine are met.

Students, staff, and educators who have been in close contact with someone who has COVID-19 and is not fully vaccinated will quarantine and contact their personal care provider to discuss diagnostic testing.

Asymptomatic individuals who have tested positive for and recovered from COVID-19 in the prior three months and asymptomatic fully vaccinated individuals do not need to quarantine or get tested. Any close contacts who test positive for SARS-CoV-2 or who
